Call to Order:

Pat called meeting to order and Aaron seconded the motion. Meeting called to order at 1:04pm. Dottie called roll call. Brian McMillan not present.

Approval of the Minutes: Dottie read the minutes and they were accepted unanimously

Commodore's report: Aaron Brandt • Trailers for sale for \$250 with no titles or tags.

• Sail shed was cleaned and all left over property needs to be identified. Cushions belonging to Larry Sallee were taken by Dean to deliver to Larry.

• Catamaran trailer is now labeled as LWSC property

• Request to run the plates on identified tagged trailers will be submitted to the FWPD.

Rear Commodore report: Absent

Vice Commodore's Report: Ted Hubble

• Thank you to all the members who have come out on their own to tackle the painting, cleaning, etc. No work party scheduled at this time but there are always projects to be done.

• Ted must be notified of ALL boats and trailers brought on to or removed from the property.

• Ted stated his objection to the lack of flexibility in the bylaws regarding moving boats off property when sold.

Discussion regarding a recent request to remove a boat that was sold was handled without flexibility was due in part to fractured communication and lack of a stated timeline. The Board will address both issues in their upcoming proposals for revisions to the by-laws. Suggested timeline is 30 days to 6 weeks from the date the title is legally transferred and a log of all transactions be compiled to assist in tracking which boats and trailers are on the property.

Treasurer's Report: Cheryl Springer

•Cheryl presented the profit/loss statement : Checking \$18,173.71 Savings \$21,732.47 Total \$39,906.18

• No solution to the credit card fees issue possibly bill once per year – encourage check draft

• Dock - \$5500 spent thus far. Need another pallet and metal to reach just shy of the T-head.

• The delinquent accounts are down to only four members. All received official notifications by phone and mail; if no response, the membership will be revoked.

Old Business:

- Driveway completed and sink holes filled but will need
- 3-4 more yards to fill low points

• A No Wake sign has been posted

Race Committee: Pat Hollabaugh

• No scheduled races. Canada Cup, Commodores Cup, and Opening Day races will be reset when Covid restrictions are lifted.

• The committee boat is coming along. Howard is working on the electronics. Pat placed on the decals. Crane for anchor installed.

New Business:

• New Member vote 49 ballots returned. Applicant Pam Hester: 49 for 0 against. She will be notified and new member packet forwarded as soon as possible.
